The Common Council of the City of Crawfordsville, Indiana, met in special session, 6:00 PM., August 2, 2010. Present were City Attorney David Peebles and Clerk-Treasurer Terri Gadd. Also present were Council members, Nellie Thompson, who chaired the meeting, Heather Perkins, Ray Kirtley, Roger Rockenbaugh, Patrick Taylor, George Parker and Denny Cook. Chairwoman Thompson called the meeting to order.

FISCAL AFFAIRS

Chairman Rockenbaugh moved to place the ordinance on third and final reading and so adopt. Seconded by Councilman Cook. Chairwoman Thompson called for the vote. The vote was unanimous to pass the ordinance.

Chairman Rockenbaugh opened the public hearing for an ordinance approving additional appropriations for the Whitlock Avenue and the Mill Street construction projects at 6:09pm. Hearing no comments Chairman Rockenbaugh closed the public hearing at 6: 10pm.

Chairman Rockenbaugh moved to place the ordinance on third and final reading and so adopt. Seconded by Councilman Taylor. Chairwoman Thompson called for the vote. The vote was unanimous to pass the ordinance.
